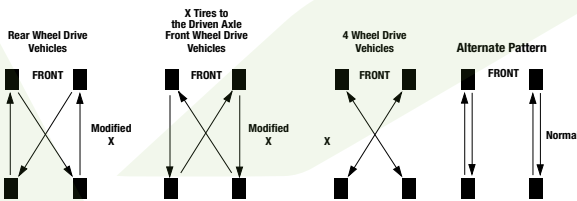
TIRE ROTATION

Important: Inspection/rotation is **required every 5,000 to 6,000 miles**. Vehicle owner/user must retain rotation record. A Tire Rotation Record has been provided on the inside panel for your convenience.

APPROVED TIRE ROTATION PATTERNS*

None of the patterns illustrated shows rotation of a spare tire. "Temporary Use" or "Mini" spares can not be included in a rotation pattern. A full size comparable spare tire (that is, same size & radial type) may be included in any of the patterns shown above by inserting the spare in the right rear position. The tire that would have moved to the right rear position becomes the spare.

*When rotating tires with a directional tread pattern, observe the arrows molded on the tire sidewall which show the direction the tire should turn. For vehicles that are equipped with different size tires front to rear, refer to the vehicle manufacturer's rotation procedures in the vehicle owner's manual.

ELIGIBILITY

This Limited warranty is effective on the PRINX tire lines listed below as of February 12, 2021, and replaces any previous limited warranties.

YOU ARE COVERED UNDER THE TERMS OF THIS LIMITED WARRANTY IF:

- You are the original purchaser of new PRINX brand passenger car or light truck tires, and
- Your tires bear Department of Transportation prescribed tire identification numbers and are not branded "NA" (Not Adjustable), or "Blem" (Blemish), and
- Your PRINX brand passenger car or light truck tires have been used only on the vehicle on which they were originally installed according to the vehicle or tire manufacturer's recommendations.
- The tire(s) must be purchased and used only in the 48 contiguous continental United States, Alaska, Hawaii, District of Columbia and Canada.
- Eligible purchasing proof must be presented to a PRINX authorized dealer.

WHAT IS COVERED AND FOR HOW LONG? NO-CHARGE REPLACEMENT

PRINX tires covered by this warranty that become unserviceable due to a defect in workmanship or material during the first 2/32nds of usable tread depth will be replaced with a comparable new PRINX tire without charge. If you are entitled to receive a no-charge warranty replacement tire, the mounting & balancing of that tire will also be provided at no charge. The cost of any other service charges, disposal fees or applicable taxes are payable by you.

PRO-RATED REPLACEMENT

Tires worn beyond the first 2/32nds of usable tread that become unserviceable due to a defect in workmanship or material will be replaced on a prorated basis. The cost of mounting and balancing and other service charges, disposal fees or applicable taxes are payable by you.

HOW PRORATED CHARGES ARE CALCULATED

The replacement price will be calculated by multiplying the dealer's current PRINX replacement tire price by the percent of tread worn out from the original tread. The cost of mounting, balancing, and other service charges, disposal fees, or applicable taxes are payable by you.

WHAT IS A COMPARABLE TIRE?

A "comparable" new PRINX tire may either be the same line of tire or, if the tire is not available, a tire of the same basic construction and quality with a different sidewall or tread design. If a higher-priced tire is accepted as replacement, the difference in price will be at an additional charge to you. Any replacement tire provided pursuant to this warranty

will be covered by the PRINX passenger car and light truck warranty in effect at the time of replacement.

WHAT IS NOT COVERED BY THIS WARRANTY?

- Tires branded or marked "Non-adjustable (N/A)", or "Blemished (Blem)", or previously adjusted.
- Irregular wear or tire damage due to:
 - Road Hazards (including punctures, cuts, snags, impact breaks, etc.)
 - Wreck, collision, fire, or vandalism
 - Improper inflation, overloading, misapplication, misuse, negligence, high-speed tire spinning, chain damage, improper mounting or demounting
 - Mechanical condition of the vehicle, including misalignment, wheel imbalance, faulty shocks or brakes
- Ride disturbance after the first 2/32nd (1.6mm) of tread depth or due to damaged wheels. "Ride disturbance" means shakes and bounces of vehicle caused by unbalanced tire-rim-assembly, out of round tires, etc., which bring unpleasant feelings or experience to drivers or passengers.
- Ozone or weather cracking on tires over four (4) years from the date of manufacture
- Alteration of the tire or addition of alien material or transfer from one vehicle to another
- Loss of time or use inconvenience, or any incidental or consequential damages
- Tires used in commercial service, unless denoted for such use as by the manufacturer
- Tires used in racing or competitive related events
- Tires purchased or used outside the Continental United States, Hawaii, Alaska or Canada

WHEN DOES THE WARRANTY END?

When a PRINX tire has delivered its full original tread life down to 2/32nds (1.6mm) remaining at any given spot in the tread area, or five (5) years from the date of original tire manufacture or new tire purchase date (without proof of purchase, date of manufacture will be used to determine age.)

HOW DO YOU OBTAIN AN ADJUSTMENT?

In order to be eligible for PRINX Limited Warranty service, the owner must:

- Present the tire to an authorized PRINX dealer; and
- Present proof of purchase (if applicable) to the dealer; and
- Pay the amount due on a new tire, less the amount of credit, including taxes, mounting and balancing charges or cost of other services ordered.

DISCLAIMER

This Limited Warranty, or any warranty stated or referred to herein is exclusive and in lieu of any other warranty regarding the quality of PRINX brand tires, whether expressed or implied, and remedies for breach thereof shall be limited to those specifically provided herein. To the extent permitted by law, Prinx Chengshan Holding Limited and TBC Brands LLC cannot be held responsible for incidental and consequential damages, loss of time, loss of vehicle use, or inconvenience. Some states do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation or exclusion may not apply to you. To the extent allowed by law (your state may not allow this limitation) and except for those stated herein, this Limited Warranty excludes and disclaims all express and implied warranties of merchantability and fitness for a particular purpose and limits this warranty to the duration stated herein. **This limited warranty applies only to consumers actually purchasing and using the tire in the 48 contiguous continental United States, Alaska, Hawaii, District of Columbia and Canada.** Obligations under this policy may not be enlarged or altered by anyone. In Accordance with Federal Law, this limited warranty has been designated as a "Limited Warranty". Nothing in this Limited Warranty is intended to be a representation that tire failures cannot occur.
